Welcome to **Kanaku** — the secure and simple password manager designed to give users full control over their credentials.

By accessing or using Kanaku, you agree to be bound by these Terms and Conditions. If you do not agree with any part of the terms, you may not use the app.

1. Use of the App

Kanaku allows you to:

- Store and manage your credentials securely on your own device
- Log in using your email and a one-time password (OTP)
- Optionally sync your data between devices using peer-to-peer encryption

You agree to use the app only for lawful purposes and in accordance with these terms.

2. Account and Email Authentication

To use Kanaku, you must provide a valid email address.

You agree to:

- Only use an email address you own or have permission to use
- Maintain control over access to your email (since it is used for login)

Kanaku uses passwordless OTP-based authentication and does not store passwords.

3. Local Data Storage and Responsibility

All credentials you enter into Kanaku are:

- **Stored locally** on your device
- **Encrypted** and not visible to us
- **Not uploaded or backed up** to our servers

You are solely responsible for:

- Managing and backing up your encrypted data
 - Keeping your device secure
 - Ensuring your data is not lost due to device failure

4. Peer-to-Peer Sync (Optional)

Kanaku offers optional sync functionality that:

- Is **manually triggered** by you
- Uses **end-to-end encryption**
- Transmits data **only between your devices**

We do not store, route, or decrypt any synced data. You are responsible for choosing when and with whom to sync your data.

5. Privacy and Data Collection

We only collect and store your **email address**, which is used for:

- One-time login

- Sync authentication

We do not collect or store your passwords, notes, or any content you enter in the app.

6. Intellectual Property

Kanaku, its name, logo, and all associated content are the intellectual property of the developer.
You may not copy, modify, or distribute the app or its branding without permission.

7. Disclaimer of Warranties

Kanaku is provided “as is” without warranties of any kind.

We do not guarantee:

- That the app will be error-free or always available
- That data will never be lost (especially since storage is local)

You use the app at your own risk.

8. Limitation of Liability

To the maximum extent permitted by law, we shall not be liable for any:

- Loss of data
- Unauthorized access to your device
- Damages resulting from your use or inability to use the app

You are responsible for maintaining your own data backups and device security.
